Vilka nyckelrisker är specifika för Värdepapperen?

Risikfaktorer förknippade med Värdepapperen: Värdepapperen är föremål för följande nyckelrisker:

- Värdet och den noterade kursen för dina Värdepapper (om något) kommer vid var tid reflektera många faktorer och kan inte förutsägas.
